Timeline for SPOT Admission into U.G., P.G. & 2 years B.Ed./ M.Ed. Courses in the Higher Education Institutions participating under SAMS for the Academic Session: 2024-25

- This is to inform all concerned that admission to the remaining vacant seats in U.G., P.G. and 2 years B.Ed. /M.Ed. courses at the Higher Education Institutions participating under SAMS will be conducted through a SPOT admission process.
- The eligibility for the aforementioned courses are mentioned in the Common Prospectus available on the SAMS portal. Accordingly, the applicants are hereby instructed to fill-up the Common Application Form by visiting the SAMS portal as per the timeline mentioned below.
- In this SPOT admission process for admission into P.G. & B.Ed./M.Ed. Courses, applicants must have appeared in the CPET-2024 & B.Ed./M.Ed. Entrance Examination respectively and must have obtained a rank.
- In the SPOT admission process, both admitted and non-admitted students are eligible to participate in U.G., P.G. & 2 years B.Ed. /M.Ed. Courses.
- If an applicant has taken admission in any of the HEIs in earlier Phase(s) and got selected in this SPOT admission round, s/he has to obtain the CLC physically from the last admitted HEI within maximum 7 days(on or before 28th Nov, 2024) from the date of selection.
- The selection of the applicants will be done purely on merit basis. There will be no reservation and weightage for this SPOT admission round.
- In the SPOT round, applicants can apply for minimum one (1) and maximum three (3) options (HEI + Subject), where seats are available for admission into U.G., P.G & 2 years B.Ed. /M.Ed. courses.
- Before applying, applicants can view the number of seats available in their desired subjects and HEIs by visiting the "Individual College Profile" option on the SAMS portal for each course.
- As per the timeline, the rank-wise merit list of the applicants will be made available in the HEI's e-Space.
- Applicants who apply for this SPOT admission round must report to their chosen HEI physically with the required documents and remain present until 03.45 PM of the reporting date to participate in the SPOT admission process. Applicants who do not report within this timeframe will not be permitted to participate.
- Further, the HEIs will prepare the merit list among the reported applicants and publish the same on their Notice Board. The selected applicants will be informed by the HEIs to validate their documents and pay the full admission fees directly at the respective HEI and complete their admission process.
- The HEIs are requested to fill up the remaining vacant seats by calling the reported applicants rank wise till the last date of admission updation.
- The timeline for all the aforementioned courses are as mentioned below.
